Conference Venue



The Conference will be held in the beautiful town of Nessebar, Bulgaria.

Often referred to as the "Pearl of the Black Sea", Nessebar is a rich town-museum defined by more than three millennia of ever-changing history.

It is a one of the most prominent tourist destinations and seaports on the Black Sea, in what has become a popular area with several large resorts—the largest, Sunny Beach, is situated immediately to the north of Nessebar.

Nessebar has on several occasions found itself on the frontier of a threatened empire, and as such it is a town with a rich history. The ancient part of the town is situated on a peninsula (previously an island) connected to the mainland by a narrow man-made isthmus, and it bears evidence of occupation by a variety of different civilisations over the course of its existence. Its abundance of historic buildings prompted UNESCO to include Nessebar in its list of World Heritage Sites in 1983.



Accommodation



Accommodation at special prices has been reserved for participants in the four stars Festa Panorama Hotel (conference hotel) situated on the pedestrian promenade of New Nessebar, only a few minutes away from the Old town, 150m from the beach. The hotel offers swimming pools, sauna, SPA and beauty centre, and other facilities.

The hotel was completely renovated in 2015.
